RESOLUTION N<sup>o</sup> 5, 2009

### SETTING THE TAX LEVY RATE

THE WILLIAM SHORE MEMORIAL POOL DISTRICT BOARD OF COMMISSIONERS finds as follows:


1. The William Shore Memorial Pool District (WSMPD) was formed pursuant to an election of the citizens residing within the boundaries of the Port Angeles School district on May 19, 2009.
2. The proposition placed before the people at that election included a statement that the tax levy for the WSMPD was estimated to be fifteen cents per thousand dollars of assessed valuation.
3. The WSMPD Board of Commissioners has developed estimates of the costs needed to operate the pool in 2010, including amounts to repay a transition loan from Clallam County.
4. These estimates indicate that the WSMPD can be operated within the amount of revenue that would be raised by a fifteen cent per thousand tax levy.
5. Because of requirements of the Clallam County Assessor and the Washington State Department of Revenue, the WSMPD is required to make its actual levy in a dollar amount, rather than using a tax rate.
6. Based upon the most recent estimates of value from the Clallam County Assessor, the WSMPD has calculated that fifteen cents per thousand tax rate will return to the district Four Hundred and Seventy five thousand dollars, sufficient revenue to meet its operating costs.
7. The WSMPD Board of Commissioners therefore determines that it can meet the intent of the ballot proposition than the tax rate not exceed fifteen cents per thousand dollars of assessed valuation by levying \$475,000

NOW, THEREFORE, BE IT RESOLVED by the William Shore Memorial Pool District Board of Commissioners, in consideration of the above findings of fact:


1. That the tax levy rate used by the district for the 2010 tax levy shall be fifteen cents per thousand dollars, expressed in the actual tax levy resolution as Four Hundred and Seventy Five Thousand Dollars (\$475,000.00)




