AGENDA ITEMS

1a State Auditor Report- Exit Conference Packet

State Auditor's Office members Tina, April, and Carol gave a presentation of audit findings, responses, and answered questions from the Board. Discussions surrounded the cash and accrual basis and how to update and improve our financial reporting for future audits. The report will be published and accessible in a little over a week.

ITEMS FOR DISCUSSION

2a Executive Director Report- *Steve Burke went over the audit with the Board, discussing cash and accrual basis reporting. Steve and Jessica then addressed the recent increase in patron incidents at the facility, including having to trespass multiple members in the last week. The Board applauded management for prioritizing a healthy and safe workplace for especially young employees.*

2b Financial Report- *Steve gave the financial report in Chris's absence. The Board went through highlights of the audit report and were happy with the outcome of the audit presentation made by the CPA's and audit managers. Steve and members of the Board then discussed investment options and other future financial changes with the loosening of COVID-19 protocols and capacity limitations.*

2c Staff Report- *Jessica Compton reported an increase in lap swimmers, consistent number of reservations, and a record high for monthly revenue for memberships and admissions. The community yard sale raised \$1,500 for SPARK Squad and the 11 community booths requested this become an annual event. Swim Club had their first meet against Kitsap and Boys swim team is in their season as well. Jessica addressed future changes in reservations and capacity*

due to the opening of the state on June 30th and how that will affect aquatic centers and programming.

2d Advisory Committee Report- No Advisory report with Steve Z. not in attendance and no weekly meeting.

PUBLIC COMMENT- Linnea Martin addressed Steve and the Board via Zoom about the pool's temperature and why it was chosen. She relayed community comments of the dive tank being too cold for some elderly patrons to return. Steve assured her the temperature was chosen to please as many swimmers as possible, stating the Wellness pool being built specifically for the benefit of these patrons needing warmer water for therapy reasons and the lap lanes for the members needing colder water for lap swimming health.
