## RESOLUTION № 2-2016

AUTHORIZING THE APPLICATION FOR AND RECEIPT OF AN OPPORTUNITY FUND GRANT FOR THE WILLIAM SHORE MEMORIAL POOL DISTRICT EXPANSION PLAN DESIGN

- The Executive Director is authorized to apply to the Clallam County
  Commissioners for an Opportunity fund grant for the design and cost
  estimating phase of the expansion project for the William Shore Memorial Pool
  facility.
- 2. Any fund assistance received shall be used for implementation of the project referenced above;

- 3. The District hereby certifies that the project is included in the District's 2016 Capital Facilities Plan;
- 4. This resolution shall become a part of the District's application to the Clallam County Opportunity Fund;
- 5. The Executive Director is hereby authorized to receive any funding for the project from the Clallam County Opportunity Fund, to execute all documents necessary to receive and use such funding, and to maintain an accounting of the proceeds to ensure the use of the funds for the above referenced project.
- 6. It is hereby acknowledged that Commissioners Bill Peach and Mike Chapman are abstaining from voting on this resolution due to their conflict of interest as both Clallam County Commissioners and District Commissioners.
